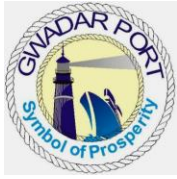


INVITATIONS FOR BIDS

1. The Employer, Gwadar Port Authority, Ministry of Maritime Affairs, Government of Pakistan, desires to construct its GPA Business Complex R.O.D. Plant (0.2MGD) at GPA Business Complex, Gwadar.
2. The Employer invites sealed Bids from eligible firms registered with PEC in the Category C-3 or above with specialty codes CE03 & ME06, for the execution of following work:

3. Bid will be Post Qualified on the basis of information provided by the bidder. Bidder(s) who fail to qualify in this respect shall not be considered.

A complete set of Bidding Documents can be obtained on submission of a written application and upon payment of a non-refundable Bidding Document cost in the shape of pay order in favor of Gwadar Port Authority (GPA) from the office of Director (M&C) Works, Pak China Friendship Road, Gwadar Port, Gwadar. 5. Pre-Bid meeting will be held on **25th March 2019 by 1100 hrs** in the GPA Nucleus Office, 6 Sunny Side, Civil Lines, Karachi.
6. Single Stage Two Envelope bidding process will be adopted. One envelope shall be clearly marked "TECHNICAL PROPOSAL". Second envelope containing the Priced Bidding & Contract Documents shall be clearly marked "FINANCIAL BID DOCUMENTS".
7. "FINANCIAL BID DOCUMENTS" shall be accompanied by Earnest Money/Bid Security in the form of Deposit at call or a Bank Guarantee issued by a Scheduled Bank in Pakistan or from a foreign Bank duly counter guaranteed by a Scheduled Bank of Pakistan. "Technical Proposal Document" shall be accompanied by the proof (copy) of Earnest Money/ Bid security.

Bids received after the prescribed time and date shall be rejected.
9. Financial Bid Documents of the Bidders, who technical bids are failed to qualify, shall be returned unopened. Gwadar Port Authority shall not entertain any claim on the basis of cost incurred by the bidders for preparation of the Bid.
10. The envelope of the "Financial Bid Document" of technically qualified bidders will be opened in the presence of their representative at a time to be determined later on.
11. Gwadar Port Authority reserves the right to accept or reject any or all bids in the light of Public Procurement Regulatory Authority (PPRA) Rules.
