Sealed Bids are invited from firms having vast experience of construction works in similar structures and are registered with Pakistan Engineering Council in Category C4 or above.

3. A complete set of Bidding Documents and Post Qualification Documents may be purchased on submission of a written application to the undersigned and upon payment of a non-refundable Bidding Documents cost in shape of demand draft / pay order in favour of Gwadar Port Authority.
4. Pre-Bid meeting will be held on December 23, 2016 in the GPA Head Office, Gwadar.
5. Single Stage Two Envelopes procedure will be adopted. One envelope containing information regarding Post Qualification of the Bidders shall be clearly marked "TECHNICAL QUALIFICATION INFORMATION" prepared as per instructions of Post Qualification Document. The second envelope containing the Priced Bidding & Contract Documents shall be clearly marked "FINANCIAL BID DOCUMENTS".
6. Bid shall be accompanied by Earnest Money/Bid security @2% of the bid cost in the form of Bank Guarantee, Bank Draft/Pay order or Insurance Guarantee drawn in favour of "Gwadar Port Authority" in a Separate Envelope with "Technical Qualification Information Document"

7. Partial & incomplete bids will not be considered. Technical Qualification Information and Financial Bid Documents (both envelopes) are to be submitted at GPA Head Office, Gwadar on or before January 02, 2017 at 1000 Hrs. The envelope containing Technical Qualification Information shall be opened on the same date at 1030 Hrs in the presence of those bidders who wish to attend. Bids received after the prescribed time and date shall be rejected.
8. The Financial Bid Documents of the Bidders who fail to Post Qualify shall be returned unopened. Gwadar Port Authority shall not entertain any claim on the basis of cost incurred by the Bidders for preparation of the Bid.
9. The envelope of the "Financial Bid Document" of Post Qualified bidders will be opened in the presence of their representative at a time to be determined.
